### 4. FIRST-AID MEASURES

## 5. FIRE FIGHTING MEASURES

<b>Suitable Extinguishing Media</b>	Use water fog, foam, dry chemical or carbon dioxide (CO <sub>2</sub> ) to extinguish flames. Water may be ineffective but can be used to cool exposed containers and structures and disperse flammable vapors. Minimize breathing of gases, vapor, fumes or decomposition products.
<b>Specific Hazards Arising From The Chemical</b>	This product is highly flammable and forms explosive mixtures with air. ## 7. HANDLING AND STORAGE

<b>Precautions for Safe Handling:</b>	Avoid contact with skin, eyes and clothing. Do not breathe vapors or mists. Wear protective clothing and equipment. Use only with adequate ventilation.
